

FOLK CAMPS SOCIETY LIMITED DEVELOPMENT GRANT SCHEME

OBJECTIVE

To provide financial aid to individuals or groups of Folk Camps Society Governing Members to undertake projects in pursuant of the provisions of Memorandum of Association No 3.

Only Governing Members of at least 12 months standing are eligible to apply.

ASSISTANCE AVAILABLE

Grants will normally be limited to a maximum of £1000

Capital equipment grants will not exceed 25% of the validated receipt value, subject to a maximum grant of £1000.

Any grant earning project must normally provide a material benefit* to the Society, the form of which will be formally agreed with the Awarding Committee before any monies are released. (** not necessarily a financial return or a physical result (eg a book) - abstract benefits such as enhanced reputation and wider publicity for FCS are equally as valid*)

APPLICATIONS

These must be in writing, setting out full information regarding the purpose of the proposal, expected outcomes, timetables and costings. A standard form has been provided to assist in the submission.

All applications will be acknowledged in writing and decision of the Awarding Committee will be sent in writing as soon as is possible after consideration.

ADJUDICATION

Applications will be considered by the Awarding Committee in strict order of receipt.

The Awarding Committee will consider the application by electronic communication.

Applications will be judged entirely on the merits of the project proposed. The form of report/feedback/other result required from the successful applicants will be decided on by the Awarding Committee

The decision of the Awarding Committee will be final and not subject to any rights of appeal by any applicant.

The Awarding Committee will comprise of 5 members (2 elected directly from the Governing Membership, 2 appointed from the Council of Management and the Administration Manager of FCS (non-voting))
